### REQUIRED REFRESHERS FOR JUDGES WHO HAVE LAPSED LESS THAN THREE YEARS

**ACCREDITED JUDGES:** Attendance requirements and pass (70+) point scoring examination at TWO Symposiums or TWO FSS Courses III or IV, or a combination of these, plus judging and exhibiting credits as described below.

**LIFE, MASTER & JUDGE EMERITUS:** Attendance requirements at TWO Symposiums. Life Judge must take pt. scoring tests.

**ALL REFRESHERS:** FOUR MONTHS must elapse between Refreshers & only TWO Refreshers may be taken in a calendar year.

**LAPSED JUDGES:** If Judge has lapsed 3+ years, but less than 6 years, an additional symposium with written point scoring test must be taken.

**LAPSED & EMERITUS-MASTER JUDGES:** A Judge who has lapsed longer OR WITH Emeritus status longer than 6 years loses all judging status.

**EMERITUS JUDGE:** Four months after an individual again becomes an Accredited Judge, she/he may attend one symposium with written point scoring test for credit. If she/he passed, the judge will immediately be returned to Accredited-Master status.
