2015 Fall Board Meeting Final Report

Nancy Bahn, Federated Garden Club of Missouri, Inc. President, gave the final report of the 2015 Fall Board Meeting in St. Louis, Missouri. The surplus was \$2,755.13 with NGC receiving \$2,066.35 and East Central District of Missouri receiving \$688.78, a 75%/25% split.

2015 Convention Final Report

Ann M. Fiel, Chairman, gave the final report of the 2015 Convention in Louisville, Kentucky. The surplus was \$20,424 which will be split equally between NGC and The Garden Club of Kentucky, Inc.

Program/Budget 2016 Fall Board Meeting

The tentative program and proposed budget for the 2016 Fall Board Meeting in Portland, Maine were presented.

Adoption of Budgets for 2016-2017

Betty Grimes, Treasurer and Budget Committee Chairman presented the annual budgets of the General Fund, the Scholarship Fund, Operation Wildflower Fund and the PH&E Fund for 2016-2017.

The budgets of the General Fund, the Scholarship Fund, and the Operation Wildflower Fund were approved and will be submitted to the convention body for adoption.

The PH&E budget was ADOPTED by the Board.

Report on Standing Rules Amendment Referred to Finance Committee Gay Austin, Second Vice-President and Finance Committee Chairman, reported that the Finance Committee recommends that the board not consider any changes to Standing Rules relative to Affiliate and International Affiliate dues until after the membership votes on the bylaw amendments at this convention. The Finance Committee also recommends that the proposed Standing Rules amendment to AFFILIATES 1. a. b. and c. referred to the Finance Committee be Postponed Indefinitely and that 1 c. (stating that there be a reinstatement fee of \$100) be dropped.

Motion to Postpone Indefinitely consideration of Standing Rule amendment to AFFILIATES 1. a., b, and c.

2) That payment of the invoice dated 10/15/2015 from Sparks Milling Company for \$35,912 for Web App prototype for the Flower Show Handbook be approved. Payment is to be taken from the Wildflower Fund in 2015-2016 fiscal year.

3) That payment of \$28,325 to Sparks Milling Company, with money to be taken from the Floral Design Publication Fund, for final formatting, punctuating, numbering, and other editing as necessary to prepare digital document file (Word or InDesign or similar) of the *Handbook for Flower Shows*.

ADOPTED AS AMENDED

4) That estimate #591775 from Sparks Milling Company for NGC website operations 3-year maintenance & tech support from 6/1/2016-5/31/2019 for \$181,824, with annual payment of \$60,608 to be discounted 5% to \$57,577.60 (included in 2016-2017 budget).

ADOPTED

5) That the concept of a second NGC book for youth be funded from Member Services with the proceeds from *The Frightened Frog*. The book will be available for purchase beginning with NGC Convention, May 2017.

ADOPTED

6) That an amount not to exceed \$1,800 be approved for the fee of artist, Emily Lackey, to illustrate the second book for youth, to be funded from the proceeds of The Frightened Frog/Member Services and to be sold at the NGC Convention, May 2017.

ADOPTED

7) That Binder PR and Marketing Communications be approved to edit *The National Gardener* through the end of 2016 at a cost of \$6,000 per issue.

ADOPTED

That NGC create a program for online membership, with costs to be approved at a later date.

ADOPTED

9) That the submitted *Plant It Pink* logo be approved.

ADOPTED

10) That the sale of *Plant It Pink* garden markers through Member Services be approved.

ADOPTED

11) That NGC accept North Dakota State Garden Clubs' invitation to host NGC's 2020 Fall Board Meeting.

ADOPTED

12) That NGC accept The Garden Club of Ohio, Inc.'s invitation 2022 Fall Board Meeting in Cincinnati, Ohio.

ADOPTED

13) That major changes, additions, and/or deletions to the *Handbook for Flower Shows* can ONLY take effect in July of odd-numbered years, after publication in the Winter Issue of The National Gardener in odd numbered years. All changes must be approved by the Board of Directors prior to the annual convention board meeting of odd-numbered years. (Housekeeping changes such as numbering, lettering, formatting, and/or grammatical/punctuation errors are not classified as major changes.) The Winter Issue of *The National Gardener* is the first issue of the stated year.

14) That the concept of the development of photography education as part of the Flower Show Schools be approved.

1) That NGC host a photography contest honoring the National Parks for Fall Board 2016, Portland, Maine. Photographs will be submitted electronically with 30 finalists chosen for display. Entry forms will be submitted and payment sent to NGC, \$15 for one image, and up to two more for an additional \$5 each. Photographs will be judged by an art group in Portland, Maine. Entries for the contest will close August 1, 2016. The printing cost of the 30 finalists will be taken from the registration fees. Winning entries will receive a certificate from NGC.

11) That the concept for a combined handbook applicable to the ES, GS and LD schools be approved by the Executive Committee, with the NGC Convention 2017 as the target date for completion. The Handbook will contain a common section containing information and requirements applicable to all three schools and separate tabs for each school, listing any information and requirements pertinent only to each school. Reproduction and distribution of the Handbook is to be carried out in the same fashion as currently exists for distribution of the current individual school handbooks.

1. MEETINGS AND NGC SPONSORED EVENTS, CONVENTIONS, FALL BOARD MEETINGS, EXECUTIVE COMMITTEE MEETINGS, Page 12

ADD 27. There shall be no Affiliate events included in the NGC schedule from the beginning of the Board of Directors Meeting until the end of the Convention or Fall Board Meeting.

2. THE NATIONAL GARDENER, Page 23-24 STRIKE 8 through 11.

- 8. The NGC Convention Chairman and Vice Chairman of the even numbered years and the odd numbered years shall be listed as members of the Board of Directors following ratification by the Board.
- 9. Following the report of the NGC Convention Chairman at the Fall Board Meeting that follows that NGC Convention, the names of the NGC Convention Chairman and the Vice Chairman will be deleted from the roster and following that meeting will no longer be Members of the Board of Directors in that capacity.
- 10. The Fall Board Meeting Chairman and Vice Chairman shall be listed as members of the Board of Directors following ratification by the Board.
- 11. Following the report of the Fall Board Meeting Chairman at the NGC Convention that

follows that Fall Board Meeting, the names of the Fall Board Meeting Chairman and Vice Presidents will be deleted from the roster and will no longer serve as members of the Board of Directors in that capacity.

Bylaw Amendments

1. Article VII - DUES, FEES AND CONTRIBUTIONS. Section 1. - Dues

A. 4. State Garden Clubs failing to remit dues by October 31 shall be excluded from any tabulations used to determine NGC Awards and shall not be eligible to submit Scholarship applicant(s).

ADOPTED

To be submitted to the membership for adoption.

2. Article VIII OFFICERS – ELIGIBILITY

Section 1. G. Officers shall be elected for a term of two (2) years, or until their successors are elected. No elected officer shall serve more than one term in the same office except the Recording Secretary who may serve non-consecutive terms and the Treasurer who may serve no more than five (5) consecutive terms.

3. Article IX- DUTIES OF OFFICERS ELECTED OFFICERS, Section 5. Third Vice-President

E. Be responsible for publishing changes to NGC Standing Rules.

ADOPTED

To be submitted to the membership for adoption

4. ARTICLE XVI Section 5. MEMBERSHIP COMMITTEE

The Membership Committee shall consist of a Chairman appointed by the President with a minimum of six (6) members on the committee. The First Vice President/President elect shall serve as ex officio a member of this committee.

To be submitted to the membership for adoption.

5. ARTICLE XVI Section 6. ORGANIZATION STUDY COMMITTEE

The Organization Study Committee shall consist of the Third Vice-President as Chairman and no more than eight members appointed by the President. The Vice Presidents Second Vice President, the Parliamentarian and the Executive Director shall attend the meetings and participate except for the right to make motions and the right to vote. The 1st Vice President may attend as a guest.
