Recommendations for Adoption

  - Corporate donations
  - NGC Endowment Fund Allocation 100% of NGC's percentage of revenue from the meeting surpluses received
  - Any unrestricted donation received by NGC
  - Donations to NGC per attendee on NGC tours
  - Transfer from any inactive NGC Restricted Funds
  - At the end of each fiscal year, transfer the remaining funds (revenue over expenses) from the General Fund to PLANT AMERICA
  - Brent & Becky's 'Plant America' daffodil sales

2. That NGC sponsor a twelve-day tour to New Zealand in November 2020, at a cost not to exceed \$5,500 per person based on two sharing a room. Price will not include airfare from the United States or optional trip insurance.

3. That the Independent Contractor Agreement between NGC and Binder PR and Marketing Communication be renewed. (Compensation for service of completion of each issue of *TNG* will be \$7,500.)

4. That the appointment of a Special Committee, the Website Development Committee, be

approved with Phyllis White as Chairman and Poss Tarpley, Jane Waugh, Gerianne Holzman, and the three Vice-Presidents: Mary Warshauer, Brenda Moore, and Donna Rouch as members. Executive Director Michelle Smith will serve as Advisor.

5. That all NGC School listings be published in *Keeping In Touch*.

6. That the following recommendations from the Flower Show School Committee be adopted:a) Handbook, page 116, prior to Section V (Becoming an Accredited Judge)Additions:

Note: Judging Credit: for Accredited, Accredited Life and Accredited Master Judges is defined as judging six (6) classes in an NGC Flower Show.

- A. A Small Standard, Standard Flower Show
  - 1. Required to include at least one class of Horticulture and one class of Design.
  - 2. The other four classes may be in any of the five divisions.
    - a. Exception: Photography is not eligible for judging credit.
    - b. Includes classes of Artistic Crafts and Exploration in Botanical Arts Division.
- B. Specialty Flower Shows
  - One class of either Horticulture or Design, according to the type of Specialty Flower Show.
  - 2. Other five classes in any of the other optional divisions: Education, Youth, or Botanical Arts with the exception of Photography. *This change will take effect July 1, 2019.*

- b) Handbook, page 117, V, B.2
- A. Change wording on page 117, B.2. To now read:

Obtain three (3) additional exhibiting credits in any of the four (4) Divisions: Horticulture, Design, Education and Botanical Arts, with the exception of Photography. *This change will take effect July 1, 2019.*

c) Handbook, page 119, VI, TABLE at bottom of the page (Accredited Life Judge to Accredited Master Judge Requirements)

Statement 2. Reword:

Earn at least two (2) exhibiting credits, including at least one (1) ribbon in either Design, Botanical Arts Design, including Artist Crafts Section, and one (1) in either Horticulture or in Botanical Arts Horticulture in a Small Standard, Standard or Specialty Flower Show, for **each** year or part of a year, between refreshers. An alternate exhibiting credit may be earned for a judged/critiqued Horticulture or Design exhibit for a practice or a written point-scoring exam in an NGC Flower Show School or Symposium. *This change will take effect July 1, 2019.*

d) Handbook page 120, TABLE at top of page (Maintaining Accredited Master Judge Certification)

Statement 1. Reword:

Must earn one (1) ribbon in either Horticulture or Botanical Arts Horticulture and one (1) ribbon in either Design or Botanical Arts Design, including Artistic Crafts Section, in Small Standard, Standard or Specialty Flower Show for each Symposium attended for credit. An alternate exhibiting credit may be earned for a judged/critiqued Horticulture or Design exhibit for a practice or written point-scoring exam in an NGC Flower Show School or Symposium.

This change will take effect July 1, 2019.
