Budgets

The annual budgets of the General Fund, the Scholarship Fund, Operation Wildflower Fund and the PH & E for 2010-2011 were presented by the Treasurer.

The budgets of the General Fund, the Scholarship Fund, and the Operation Wildflower Fund were **APPROVED** and will be submitted to the Convention body for adoption.

The PH&E budget was RATIFIED.

Recommendations

Robin Pokorski, Recording Secretary, presented the following recommendations on behalf of the Executive Committee:

For Adoption

1. That the bid from Chris Scherer to serve as editor for the *Horticulture by Types* book be accepted as follows:

Editing and project coordination, two rounds of revisions - \$4,000 Design and layout, two rounds of revisions - \$6,000 A 33% deposit for editing and layout is required, other specifics outlined in his written bid.

ADOPTED

 That all new Life Member attendees at the annual NGC Convention Life Member Banquet be given a Life Member charm or lapel pin, cost to be expended through Member Services.

ADOPTED

3. That the Natural Disasters USA Committee be authorized to increase grants of money from \$500 to a maximum of \$5,000 per natural disaster project.

ADOPTED

4. That the deadline for Award of Excellence applications be changed from November 15 to January 1.

ADOPTED

5. That the name of Landscape Design Study Program be changed to Landscape Design Schools.

ADOPTED

- 6. That a clarification/ruling for conditions of criteria and timelines in Environmental Studies, Gardening Study and Landscape Design Schools be adopted as follows:
 - a. ES, GS, and LD Schools held back-to-back must consist of at least a two (2) day minimum for each course.
 - b. All requirements as stated in the ES, GS and LD Handbooks must be maintained; i.e., number of subjects and time allotment for each subject--ten (10) hours per course--exclusive of the examination time allotment.
 - c. Unless these requirements are met, the NGC Schools Chairmen have the final authority to grant or not grant approval or accreditation for a state school course or event.

ADOPTED AS AMENDED

The recommendation that "No more than two back-to-back

7. That the following be added to the Handbook, page 112, G.2. d. Trough:

Other accessories such as plastic or ceramic animals, mirrors, miniatures, trellises, garden tools, figurines, etc. are not permitted.

19. That the printing of 17,000 copies of the 2012 Vision of Beauty calendars at a cost of \$2.15 each, subject to approval of the Finance Committee, be ratified.

20. That the authorization for NGC President Renee Blaschke to negotiate an extended timeline with Pineapple Press for the printing of Horticulture by Types be ratified.

RATIFIED

21. That the reprinting of 30,000 brochures at a cost of \$9,000, monies to be taken from the National Garden Project Fund, be ratified.

RATIFIED

22. That the creation of an additional section in the poetry contest called GENERATIONS OF GARDENERS be ratified. This section is for poems that grandparents have their grandchildren write and can be sponsored by the grandparent's garden club. (To be introduced at the 2011 Convention.)

RATIFIED

23. That the disqualification of ES, GS, and LD Schools/Refreshers held without prior NGC accreditation and the establishment of a six-week timeline for ES, GS, and LD School chairmen to submit rosters following the conclusion of a course, refresher or multiple refreshers be ratified. (This ruling would apply to state-sponsored, regional-sponsored and NGC-sponsored courses/events.)

RATIFIED

24. That the compilation by the Flower Show Schools Committee of a supplement of changes to the Handbook sequentially by page number to be published on the website with hard copies available from Headquarters on request be ratified. (All current inventory will have a sticker indicating changes are available on the website.)

RATIFIED

25. That the following addition to the Handbook, page 112, G. 2. Types of combination plantings be ratified:

G.2.d. Trough. Miniature naturalistic landscape in a container designed to withstand year-round outdoor conditions.

Containers are generally constructed from stone, hypertufa, or other sturdy weather resistant materials.

Containers appear dominant with soil volume and depth greater than a dish garden.

Naturalistic additions, such as weathered wood and rocks, appropriate to the specific type landscape may be included and may be an integral part of the landscape.

The following resolutions were approved regarding the 501(c)(3) status of the Regions:

Resolved, That the regions acknowledge that they are a part of NGC and do not exist as a separate entity apart from NGC;

Resolved, That NGC delegates to the Region control over the Regions' bank accounts, scholarship decisions and the general affairs of the region subject to ultimate review and control of NGC.

Amendments to Standing Rules

On behalf of the Executive Committee, Robin Pokorski, Recording Secretary, presented the following amendments to the Standing Rules for adoption:

- 1. Under Personnel Committee Duties, page 17, strike:
 - One (1) blank copy of the Board of Directors Application form shall be placed in a kit for each State Garden club President and distributed at Fall Board meeting in the odd-numbered years. This form may also be obtained from NGC Headquarters or be downloaded from the NGC website.
 - The State Garden club shall return three (3) copies of the Board of Directors Application Form for each applicant to the NGC Personnel chairman by February 1 of the even-numbered year.
 - 3. There are three (3) Personnel Books. The Personnel Chairman shall distribute one (1) updated copy to the First Vice President and retain two (2) copies, one (1) for the files and one (1) to prepare for the First Vice President of the next administration.
 - 4. The President shall return the personnel Book to the NGC Personnel Chairman at the end of the administration.

Substitute:

 The Board of Directors Application Form shall be placed on the NGC Website prior to the Annual Meeting in evennumbered years.

- 2. Immediately following the Annual Meeting in even numbered years, applicants shall electronically submit applications to the President-Elect and the Personnel Chairman.
- 3. At the registration table at the Annual Meeting in evennumbered years, the Personnel Chairman shall provide a form
 for current board members to sign indicating whether they
 wish to be considered for a position on the next Board of
 Directors. Those current board members wishing to apply for
 a different position shall electronically submit a new Board of
 Directors Application Form immediately following the
 Annual Meeting in even-numbered years. Existing board
 members who wish to be considered and are eligible for the
 same position need not reapply.
- 4. The President shall transfer Application Forms to the President-Elect.
- The Personnel Chairman shall maintain a current list of job descriptions for Board of Directors positions and make updates as needed.
