STANDING all Accredited, Life and Master Judges and NGC instructors must continue their judging education by attending a symposium every three years. Accredited and Life judges must take exams. Only Master Judges audit for credit.

Renewals and audits **must include** exhibiting and judging evidence as required on the appropriate application form: Accredited Judges - **Form 13**. Life Judges - **Form 15L**. Master Judges - **Form 15M**. **Submit** complete application for renewal or audit to the Judges' Credentials Chair for approval at least four (4) weeks **prior** to the symposium (**by July 14, 2026**). **Mail to:** Sue Wittick, Credentials Chair.
